Dogger Bank D is a proposed new fourth phase of the Dogger Bank Wind Farm, the world's largest offshore wind farm.

Our proposals are at an early stage, and this is the first phase of consultation which opens on Tuesday 26 September and closes on Tuesday 7 November 2023.

To support the UK's need for sustainable and secure energy, we are exploring different opportunities, in parallel, to utilise the energy produced by Dogger Bank D. These are a connection to the electrical transmission system and producing hydrogen at an onshore Hydrogen Production Facility located in the East Riding of Yorkshire.
